### Terms of Payment:

- The tuition fee will be invoiced on the 1<sup>st</sup> of September and the 1<sup>st</sup> of February respectively and is to be paid within the period of 30 days.
- On registration there is a one-time registration fee of SAR 4.900.00 (excl. VAT) due, which will not be credited to the tuition fees (50% of this fee is a non-refundable administrative fee).
- Only after payment of this registration fee and submitting of all required documents, the student will be enrolled and have the right to attend our school/preschool/kindergarten.
- Deregistration of students of the DISJ must be communicated in writing at least one calendar month beforehand (deregistration form is available in the secretary's office).
- If the tuition fee of the respective term not paid in full in due time, a late fee of 1.000,00 SAR (excl. VAT) will be raised each month. Until the full settlement of all outstanding amounts grade certificates will not be handed over in the original format and the release of the student in the Noor System will not be permitted.
- You have the right to apply for deferral or late payment within the payment period. Please contact the office for further information.
