Terms of Payment:

- The tuition fee will be invoiced on the 1st of September and the 1st of February respectively and is to be paid until the 1st of the following month.
- On registration there is a one-time registration fee of SAR 4.900.00 (excl. VAT) due, which will not be credited to the tuition fees (50% of this fee is a non-refundable administration fee).
Only after payment of this registration fee and submitting of all required documents, the student will be enrolled and have to the right to visit our school/preschool/kindergarten.
- Deregistration of students of the DISJ must be communicated in writing at least one calendar month beforehand (deregistration form is available in the secretary's office).
- Is the tuition fee of the respective term not paid in full in due time, the "1st Overdue Notice" will be issued, with which an administrative surcharge of SAR 1.000,00 (excl. VAT) will be raised. If the tuition is not paid within 2 months of the due date, the "2nd Overdue Notice" will be issued, which will increase the administrative surcharge to SAR 2.000,00 (excl. VAT) and will prohibit the student from partaking in any lessons until payment has been made in full.
- A yearly seat reservation of SAR 3.000,00 (excl. VAT) must be paid until latest 31.05 of the ongoing schoolyear. This seat reservation will be credited to the tuition fees of the next school year and is non-refundable. If the seat reservation is not paid in due time, the student will be considered deregistered.
